STATUTORY REQUIREMENT

- ▶ Minimum Qualification - 10th Pass.
- ▶ Should have cleared NISM Series I for Currency Derivatives, NISM Series VIII for Equity Derivatives and NISM Series XVI for Commodities Derivatives.
- ▶ Display of Board at their branch.
- ▶ Rs. 50,000/- Deposit (100% cash).
- ▶ Registration with Exchanges as Authorized Partner.

COST INVOLVED

- ▶ The cost of Registration (Rs 10,000/-), For all Exchanges (NSE, BSE, FO, Currency, MCX per exchange 2000) + GST 18% = 11,800 will be borne by AP.

REQUIREMENT

- ▶ Minimum office space of 350 Sq. ft.
- ▶ Minimum no. of clients handled is 100.
- ▶ From Financial Industries.

REVENUE SHARING (Combine - Equity + Currency + Commodity)

Option 1

- ▶ Gross revenue < 50k Ratio = 60% - 40%
- ▶ Gross revenue 50k - 1 lac Ratio = 65% - 35%
- ▶ Gross revenue 1 lac - 1.5 lac Ratio = 70% - 30%
- ▶ Gross revenue > 1.5 lac Ratio = 75% - 25%
- ▶ Between AP and Prudent subject to minimum retention of 1 basis point for intra-day and 10 basis point for delivery business by Prudent. Rs. 5/- (per lot) for currency & commodity Rs. 750/- / 1 cr.

Option 2

- ▶ Partner will have a option to go for fixed brokerage slab scheme. Partner may opt for 0.01% (FO + Intraday) and 0.10% (del) & Rs. 15/- (option lot).
- ▶ Rs. 5/- (per lot) for currency & commodity Rs.750/- / 1 cr.

DP AMC SCHEME

- ▶ Demat Account opening Charges Rs. 300/-, Rs. 450/- , DP life time charges Rs. 900/- + GST.

BROKERAGE PAYMENTS

- ▶ Brokerage payments to AP will be on a monthly mode subject to registration.
- ▶ TDS will be deducted.
- ▶ Payment date would be between 7-10 of every month.
- ▶ Payments will be Net to Net Negative of their clients.

FUND TRANSFERS

- ▶ All pay out to clients will be done in T+3 by Direct credit.
